#### Eligibility: A candidate is eligible for registration for Ph.D. if he/she satisfies the following conditions:

A Master's degree in the Electronics / Microelectronics & VLSI Design / Electronic Instrumentation / Solid-state Technology / Nano-Science & Nanotechnology or equivalent in an appropriate area with a minimum of 1st class (C.P.I or C.G.P.A. greater than 6.75 on a 10 point scale if class is not provided).

GATE / NET in the concerned subject or discipline are mandatory. However, the exemption of GATE/NET for part-time PhD programme shall only be given to the applicants who are serving employee in Central/State Govt., PSU and Autonomous Bodies with minimum two years of continuous service.

### **Selection Procedure:**

The eligible candidates will be called for written test. The candidate who secures at least 40% marks in the written test will be shortlisted for interview. Interview shall be conducted on the same day. The list of shortlisted candidates for written test will be uploaded on Institute's website: www.nituk.ac.in. No separate letter/communication will be made to any individual for written test.
