Institute shall make this arrangement for which you do not have to pay anything. **No provision for accompanying person(s) is possible.**

Candidates are further requested to note and observe the instructions mentioned below carefully:-

1. Production of **original documents** to substantiate your claim in application is **mandatory**. Without original certificates, you will not be permitted for Personal Interview.
2. This call for Personal Interview is **No indication** that an appointment will be offered to you.
3. In the absence of original and valid PWD, Caste & Non-creamy Layer certificates (for concerned category candidates), the candidates, if found within the prescribed age limit, will be considered in OPEN category.
4. If you are presently serving in Central/State Govt., Semi-Govt. or Govt. Undertaking organization and if your application has not been forwarded by your employer, you will have to produce **NO OBJECTION CERTIFICATE** at the time of documents verification. In case you do not produce NOC, you will not be allowed to appear for Personal Interview.
5. You shall be paid to & fro Train/Bus fare of IInd AC from your Hometown to Srinagar (Garhwal) and back.
6. Document verification & Personal Interview shall be conducted at Temporary Campus-Academic (Govt. ITI Campus), Srinagar (Garhwal), Uttarakhand.
7. You should bring a Photo Identity Card (Driving License/Voter Card/PAN Card/Bank Pass Book with Photo/Passport or Aadhaar Card/Institute ID). Without Identity proof, candidates will not be permitted to appear for Personal Interview.
