Thank you for your interest in NIT Uttarakhand.

In response to your application for recruitment at this Institute, you have been shortlisted for the post of **Superintendent (On Contract)**. In compliance to the MHRD, Govt. of India letter vide F.No.35-4/2016-TS.III dated 11<sup>th</sup> December, 2019, the Personal Interview is discontinued at Junior Level Posts (Upto Pay Matrix Level: 6). Accordingly, the tentative schedule of Trade Test/Written Test and Document Verification is as follows:

The Trade Test shall be of qualifying nature. The candidates who qualify the Trade Test shall have to appear for the Written Test. Based on the performance in the Written Test, the merit list shall be prepared and displayed on the same day. The document verification shall be conducted only for those candidates whose name will appear in the final merit list. If the candidate fails to produce the original documents, NOC alongwith Vigilance Clearance Certificate (as applicable), at the time of document verification, the candidature shall be out rightly rejected.

The minimum qualifying marks for preparation of merit list shall be as follows:

50% Marks – General/EWS candidates	45% Marks – OBC candidates	40% Marks – SC/ST candidates

**Resolution of Tie Cases:** In case where more than one candidate secures the equal aggregate marks in the Written Test, tie will be resolved by applying the following methods one after another:

- i) Date of Birth, with older candidate placed higher.      ii) Alphabetical order in which names of the candidates appear.

You are further requested to carefully note and observe the following instructions:

1. This call letter for Trade Test/Written Test is **No indication** that an appointment will be offered to you.
2. Production of **original documents** at the time of Document Verification to substantiate your claim in application is **mandatory**. Without original certificates, your candidature will out rightly be cancelled. The SC/ST/OBC/EWS/PWD/Ex-Servicemen candidates are required to produce certificates as per Annexure-I to Annexure-V of advertisement. The OBC/EWS certificate should be valid on **1<sup>st</sup> April, 2020** or later. However, in the absence of necessary certificates proving category, guidelines issued by Government of India will be followed.
3. Institute reserves the right of not permitting the candidates to report for Trade Test, Written Test and Document verification after the scheduled time.
4. You should bring a Photo Identity Card (Driving License/Voter Card/Passport/Aadhaar Card). Without valid Identity proof, candidates will not be permitted for Trade Test/Written Test/Document verification.
5. If you are presently serving in Central/State Govt., Autonomous/Statutory Body, Public Sector Undertaking/Enterprise, Semi-Govt. or Govt. Undertaking organization and if your application has not been forwarded by your employer, **you will have to produce No Objection Certificate alongwith Vigilance Clearance Certificate at the time of documents verification**. In case you do not produce No Objection Certificate alongwith Vigilance Clearance Certificate at the time of document verification, your candidature will be out rightly rejected for the further process of recruitment and no correspondence in this regard will be entertained.
6. No Travelling Allowance (TA) shall be paid to outstation candidates for attending selection process. However, SC/ST/Divyaang candidates attending the Trade Test/Written Test shall be paid to & fro second class railway fare by shortest route by an electronic transfer at a later date, subject to production of valid tickets and caste/PWD certificate. SC/ST/ Divyaang candidates already in Central/State Government organizations, Autonomous Body, Public Sector Units etc. service are not eligible for the same. The claim may be provided in the prescribed proforma Annexure-VI of advertisement.
7. If at any time during the selection process or thereafter, it comes to the notice that the candidate has filled wrong entries/not qualified as per the Recruitment Rules of the post or fails to get verified the original certificates/testimonials as required, his/her candidature will be cancelled.
