The Chairman welcomes all the members. The Committee discussed the following agenda.

GC 06.01: To deliberate upon the matter of Dr. Lalta Prasad, Associate Professor & HoD (Mechanical) regarding non-credit of Half Pay Leave in his leave account.

Resolution: The Grievance Cell has gone through the application of Dr. Lalta Prasad and unanimously resolved that Institute administration has discontinued the credit of Half Pay Leave not only i.r.o. Dr. Lalta Prasad but for all serving faculty members of the Institute in compliance to the DOPT OM No.11020/01/2017-Estt.(L) dated 30/08/2019 and started credit of Earned Leave by the amended Rule 28 & 29 of CCS (Leave) Rules, 1972.

However, as per the grievance application, documentary proof may be sought from Dr. Lalta Prasad as per his claim that "all NITs are crediting 20 HPL to the faculty members every year along with Earned Leave". After receiving the said documents from Dr. Lalta, the Grievance Cell will re-consider the case.

GC 06.02: To deliberate upon the issue of non-grant of Transport Allowance for the month of June-2021 raised by Dr. Gurinder Singh Brar, Associate Professor (Mechanical) and Dr. Tajinder Singh Arora, Assistant Professor (Gr-I), Electronics Engg.

Resolution: The Grievance Cell has gone through the applications of Dr. Gurinder Singh Brar and Dr. Tajinder Singh Arora regarding non-grant of Transport Allowance for the month of June-2021 and unanimously resolved that Institute administration has not granted the Transport Allowance in compliance to the Department of Expenditure, Ministry of Finance OM No.21/3/2020-E.II(B) dated 01/12/2020 and No.21/5/2017-E.II(B) dated 07/07/2017 and NIT Statutes 24(iii).

Dr. Hariharan Muthusamy in the capacity of Dean (FW) has informed Grievance Cell that the meeting of Deans and HODs has been conducted and Minutes of the meeting has already been sent to Registrar through email for further instruction from the competent authority. Therefore, Grievance Cell unanimously resolved to hold the request of Dr. Brar and Dr. Arora until any directions are received from competent authority.
