SC 03.01 To consider the complaint of Mr. Neeraj Kumar, Trainee Teacher, NIT Uttarakhand.

> Mr. Neeraj Kumar, has been appointed as Trainee Teacher in the Department of Civil Engineering under Trainee Teacher Scheme. He was appointed with B. Tech. Degree. He has registered for M.Tech. and Ph.D. at IIT Roorkee.

> A complaint has been received from Mr. Neeraj Kumar regarding threat, harassment/humiliation at work place, financial distress and denying opportunities for outside employment and professional growth.

The Special Cell is requested to deliberate upon the issues.

Resolution:

The Committee interacted with the complainant Mr. Neeraj Kumar about all the points mentioned in his application. Complainant and all Committee members unanimously agreed that strike by the students and prevailing situation in the Institution at that time was unprecedented and it called for services from each faculty and staff members.

The Committee advises the Institute administration to consider issuing a general advisory to all the employee of the institute so as to sensitize the environment towards granting due dignity and mutual respect to each other, irrespective of the seniority.

As regards recovery from salary of September 2018 of the complainant, the Committee observed that such recovery has been made by the administration from all the 21 Trainee Teachers as per the approval from the Competent Authority. Hence, this point does not hold merit. However, the ambiguity in the Trainee Teacher Scheme document regarding reimbursement of Tuition fees or all fees may be referred to the appropriate Authority for further clarification.
