Resolution:

The Special Cell deliberated upon the agenda item and also referred to the resolution of the Third Meeting of the Special Cell held on 15.02.2019 (Item SC 03.01). The Special Cell after detailed deliberations resolved that Mr. Neeraj Kumar may be allowed by the Competent Authority to submit his Grievances, if any, to the National Commission of Scheduled Caste (NCSC).

SC 06.02: To deliberate upon the Implementation of Reservation in Teachers' Cadre in NIT Uttarakhand as per clarification issued by MHRD vide letter No.F.No.33-3/2018-TS.III dated 05/11/2019.

> With reference to the MHRD Letter no.F.No.33-3/2018-TS.III dated 5th November, 2019 (Annexure-II) regarding implementation of Central Educational Institutions (Reservation in Teachers' Cadre) Act, 2019, Institute is require to implement the reservation for all positions of faculty cadre.

The Special Cell is requested to deliberate upon the matter.

The Special Cell perused the MHRD Letter F.No.33-3/2018-TS.III dated 5th Resolution: November, 2019 regarding implementation of Central Educational Institutions (Reservation in Teachers' Cadre) Act, 2019.

are applicable for the purposes of appointment in NITs. Similarly, the reservation of posts in NIT Uttarakhand is to be done in accordance with the rules of Central Government.

In view of the above, the Special Cell recommends adoption and implementation of the above mentioned letter of the MHRD.

With reference to the MHRD Sanction Order no.F.No.30-1/2017-TS.III dated 31st July, 2017 whereby it has sanctioned 16 posts to NIT Uttarakhand now totaling to 86 posts. Out of which 72 faculty are in-position (including of 14 Trainee Teachers) and 14 positions are vacant. After merging Faculty (Engineering) and Faculty (Non-Engineering) total 14 vacancies are now left to be filled in the ensuing recruitment. The Special Cell deliberated upon the recasting of the reservation roster and recommends fresh reservation roster as follows:
