Applications are invited for admission to M.Tech. Full Time (Self-Sponsored) Programme in the Department of CSE, ECE, EEE, MEC and CIV for the Academic Year 2022-2023. The details are given below.

The online application form must be submitted along with scan copies of all the documents as mentioned at serial no. 4. The candidates are required to apply online and there is no requirement to send the Hard Copy of the application form to the Institute.

### 3. Important instructions to the candidates:

- a. GATE will not be mandatory. However, preference will be given to the GATE qualified candidates.
- b. An applicant is required to apply on different application forms (using different mail IDs) in case he/she wants his/her candidature to be considered in more than one Department.
- c. Valid category certificate (if applicable) has to be produced.
- d. An application fees of Rs. 500/- (Rs. 250/- for SC, ST and PWD candidates) is required to be paid online and the same is non-refundable. The detail of Institute's bank account is given below.
- e. A candidate should have at least 55% marks in B.Tech. Programme for shortlisting.
- f. In case of final Degree awaited, an undertaking in the prescribed format has to be uploaded that they shall submit the result up to 30th September 2022, failing which their admission shall automatically stand cancelled.
- g. Department will screen and consider the B.Tech. degree of the candidates to decide their eligibility for admission through written test and interview.
- h. No financial assistantship will be provided to such students.
- i. Hostel facility will not be provided to the students under this scheme.
- j. The student will be governed by the same rules and regulation as per M.Tech. Ordinance of the Institute except fees structure.
- k. A written test of 50 marks will be conducted on GATE syllabus. There will be 50 MCQ type questions for 2 hours. 30% marks (15 marks) will be the cut-off marks of the candidates to appear in interview. Interview will be conducted for 50 marks on the same day. A candidate has to score total 30 marks (out of 100 marks including written test and interview) to be eligible for admission in self-sponsored M.Tech. Programme.
- l. The finally qualified candidates will be informed by via email only.
- m. OBC-NCL/EWS certificate (if applicable) must be issued on or after 01.04.2022 by the competent authority.
- n. The candidate (in service) applying for above mentioned programmes need to apply through proper channel. Any application without "No Objection Certificate" from the current employer shall not be considered for shortlisting.
- o. The application without application fee (as applicable) and scan copies of all original documents/certificates/testimonials/undertaking shall be rejected and shall not be considered for shortlisting.
- p. Institute reserves the right to cancel the admission at any stage if found any information is incorrect.
- q. All disputes pertaining to the conduction of Examination and admissions shall fall within the jurisdiction of Uttarakhand only.



- r. The reservation rules as per Government of India norms will be followed at the Institute level on total 25 seats for admission.
- s. Candidates are instructed to visit the Institute's website regularly to get the updated schedule of admission as no personal communication will be done by the Institute.

#### 4. Following documents in originals are required for admission:

- i. 10<sup>th</sup> standard mark sheet as proof of date of birth.
- ii. 12<sup>th</sup> standard Mark sheet.
- iii. UG Grade cards/Mark sheets of qualifying examination for all semesters.
- iv. Transfer Certificate issued by the Institute last attended.
- v. Migration Certificate.
- vi. Degree/Provisional Degree certificate. If the result of qualifying degree is awaited, an Undertaking of course completion by the candidate must be provided in the prescribed format available on the website.
- vii. GATE Score card, if any. (GATE score is not mandatory for M. Tech self-sponsored candidate).
- viii. OBC-NCL/EWS certificate (if applicable) issued on or after 01.04.2022 by the competent authority.
- ix. Certificate of category (SC/ST) (if applicable).
- x. PWD certificate (if applicable)
- xi. Aadhar Card
- xii. No objection certificate (in case of employed)

#### 5. Admission Procedure and other Instructions:

- a. The selected candidates are required to report for Institute admission within 8<sup>th</sup> – 12<sup>th</sup> September, 2022 in the Academic Section, ITI campus of the Institute.
- b. Candidates are required to pay Institute fees (Rs. 80,000/-) online as specified at serial no. 6.
- c. Candidates are required to bring all the original documents as mentioned at serial no. 4 along with one set of self-attested photocopies of all the documents for admission. All the original documents have to be produced for verification. The admission letter issued by NIT Uttarakhand and fees payment receipt have also to be produced for admission.
- d. Candidates are advised to visit the Institute website ([www.nituk.ac.in](http://www.nituk.ac.in)) frequently to get more updates/any change in schedule of Institute admission/other information.
- e. Bring 10 Passport size color photographs.
- f. Candidate is required to submit anti-ragging undertakings online through [www.antiragging.in](http://www.antiragging.in). **Step 1:** Log on to [www.antiragging.in](http://www.antiragging.in) or [www.AMANMOVEMENT.org](http://www.AMANMOVEMENT.org). Click on the button called – Register for Undertaking. **Step 2:** Select your University as 'NIT Uttarakhand' and fill all the information by providing college number '9557750897' as required and submit the form. **Step 3:** On successful submission, you will receive an e-mail with your registration number and a web link. ## 7. How to reach NIT Uttarakhand Campus:

Temporary Campus is located in Govt. Polytechnic College, Srinagar Garhwal (Distt. Pauri Garhwal, Uttarakhand) at Srinagar. Srinagar is about 105 KM from Rishikesh on National Highway No. 58 leading to Badrinath (about 193 KM from Srinagar). Rishikesh is the nearest Railway Station. Haridwar, a major Railway station in Uttarakhand is about 140 KM from Srinagar Garhwal. Nearest Airport at Jolly Grant, Dehradun is about 125 KM away from Srinagar Garhwal. Taxis are available for Srinagar Garhwal from Airport. Buses and Taxis are available for Srinagar from Dehradun/Rishikesh/Haridwar. It takes around 3 hours to reach Srinagar from Rishikesh. In rainy season, road may be blocked due to land sliding. Candidates are requested to keep a spare day while planning for reporting. Alternate way to reach Srinagar is from Kotdwara (via Pauri), which is about 140 KM and takes around 5 hours.
