Resolution: The Council deliberated on the agenda and decided to extend tuition fee waiver to SC/ST/PH M.Tech students in NITs & IIEST where such fee waiver is not available to SC/ST/PH M.Tech students.

In NIT Uttarakhand, there is no fee waiver for M.Tech students till date but other NITs (except Durgapur & Agartala) are providing fee waiver to M.Tech scholar as per council decision. It has resulted in less than 10% seats of M.Tech filled in the Institute.

The Board is requested to approve fee waiver to M.Tech students in NIT Uttarakhand as per council decision and recommendation of Senate of NIT Uttarakhand in its 38th meeting vide agenda item no "S 38.08".

BoG 51.12: Adoption of MoE letter dated 11.09.2023 regarding revision of emoluments and guidelines on service conditions for research personnel engaged in R&D programme of the Central Government Department/Agencies.

Institute in receipt of MoE Letter vide F.No.12-2/2023-U1 dated 11.09.2023 regarding revision of emoluments and guidelines on service conditions for research personnel engaged in R&D programme of the Central Government Department/Agencies.

The Board is requested to approve the implementation of MoE letter dated 11.09.2023 for revision of emoluments as per recommendation of Senate in its 38th meeting vide agenda item no S 38.11.

BoG 51.13: To increase the number of Institute fellowship for Ph.D.

As per the approval of 15th Senate vide agenda item no.S 15.07 and 20th BoG vide agenda item no. BoG 20.16, annual intake of 40 Ph.D. students was approved since Institute had 40 Ph.D. holder faculty at that time. The Institute is having 86 sanctioned post of Faculty. In addition, as per Senate resolution vide agenda item S11.04, each faculty can supervise only 2 Ph.D. students with Institute fellowship (MHRD scholarship).

At present, the number of Ph.D. holder faculty has increased and a proposal for increasing the Institute fellowship has been placed in the Senate vide agenda no. \$38.14 and the resolution is as under:

"Senate resolved that annual intake of Ph.D. program with Institute fellowship be increased from 40 to 60 in view of no. of Ph.D. holder faculty members increased from 42 to 62 at present. A faculty can supervise any number of Ph.D. student with maximum 03 Institute fellowship at a time."

As per Senate resolution vide agenda item no S 38.12, Annual Intake of B.Tech Program was increased from 180 to 200 (other than DASA & SII category). Admission process for all 200 seats will be through JoSSA.

The Board is requested to approve increased intake of 200 seats for B.Tech programme as per recommendation of Senate.

BoG 51.16: To apprise the Board about the land allotted for the construction and development of Infrastructural facilities at NIT Uttarakhand- Sumari Campus.

Subsequent to the completion of tendering process NBCC (India) Ltd informed vide its letter no NBCC/RBG/(UP/UK/NCR)/UKD/2023/917, dt: 27.09.2023 that in order to obtain NOC from forest department the details of khasra/ khatuani of land were required. Communication was done with Revenue Department to provide the land details and Sub Divisional Magistrate Srinagar informed vide its letter no 512 dt: 13.10.2023 to deposit ₹1,47,855/- in the Government account head 0029008000600 as a demarcation fee. Institute deposited the aforesaid amount on date 13.10.2020.

The revenue department, Srinagar Pauri Garhwal provided the Khata- Khatauni number of the 60 acres land. It was informed by them only 49.916 acres it was informed that the land details are available against 60 acres of land to be developed as per approved layout plan which is otherwise in the possession of NITUK within boundary constructed by NBCC at a fatal cost of 3.33 crores in year 2015-16. The Land details of approx. 10 acres are not available. Further, out of the 49.916 acres land, as per record, around 39.8673 acres land is registered in the name of NIT Uttarakhand and approx. 10 acres (2.3616 acres Private Land + 7.6868 acres Government land) of land is not registered in the name of NIT Uttarakhand. The details of land which is not registered in the name of NIT Uttarakhand along with Khasra numbers are attached herewith as letter 512 dt 30.10.2023.

To resolve the above-mentioned issues, communications were done with District Magistrate, Pauri Garhwal and Revenue Secretary, Govt. of Uttarakhand. A meeting was attended at the office of Revenue Secretary, Uttarakhand Govt. A meeting was conducted by the Honorable Minister of Education in New Delhi on 15.11.2023 in context to the land-related issue faced by the institute. In context to this meeting, District Magistrate, Pauri Garhwal and Hon'ble Director, NIT Uttarakhand along with their teams visited Sumari to find out a viable solution to the land issues of private land (about 2.36 acres), government land (about 7.68 acres) and unidentified land (about 10 acres) with in the 60-acre land portion. In this regard, the District Magistrate informed that the District Administration would resolve the issue of all the middle patches of private land and transfer it in the name of NIT Uttarakhand. It was assured by the District Magistrate that very soon a clear parcel of 60 acres land with complete mutation details along with a Khasra map will be provided to NIT Uttarakhand.

Sub Divisional Magistrate vide its letter no 02/वाचक/2023-2024, dated 20.11.2023 provided the 60 acres land parcel consisting of the land which is either registered in the name of NIT Uttarakhand or in the name of the State Government. Out of this 60

but

acres land about 54.86 acre land is registered in the name of NIT Uttarakhand and 5.33 acre land is currently registered in the name of State Government of Uttarakhand and as informed by Revenue Department very soon it will be mutated in the name of NIT Uttarakhand

When this newly proposed land is compared to previous land, it is observed that the hostel blocks, main gate, and Electrical Sub-Station building as per the approved layout and DPR do not overlap, and due to which these buildings need to be shifted. In the ILPMC meeting held on dt 30-11-2023, it has been decided that these buildings can be realigned with the newly proposed land. Apart from the aforementioned construction blocks, the majority of buildings can be built on their originally proposed sites. In this regard, communication has been done with NBCC (India) Ltd. to informed about the feasibility of construction without any escalation in cost w.r.t. approved cost of the project. If NBCC is agreed to give feasibility within same budget, then AA&ES may be awarded to NBCC (India) Ltd.

The Building and Works Committee was also apprised of the above developments vide agenda item BWC 21.03 dated 04.12.2023. The resolve of the BWC is as follows: Resolve BWC 21.03: "(a) The technical quality of newly allotted land and its suitability for safe construction shall be evaluated by a technical team of PMC i.e. NBCC (India) Ltd., (b) Institute shall pursue with the district administration to get demarcation of entire 60 acres land and its transfer in the name of NIT Uttarakhand in the revenue records, and (c) Subsequently, Institute shall also process the demarcation of the remaining 250 acres of land."

All related documents/ letters are enclosed in (Annexure BoG 51.08)

The Board is requested to deliberate the same.

BoG 51.17: To apprise the Board about the approval of HEFA for the additional sanction of ₹54.10 crores.

Institute was sanctioned ₹596.75 crores for Sumari campus. NBCC informed that the L1 cost of tender is ₹650.85 crores. Institute approached MoE for additional ₹54.10 crores through HEFA to meet cost of construction of Sumari campus. Institute informed HEFA that Ministry of Education, Govt. of India, New Delhi has approved the proposal of NIT Uttarakhand towards release of additional fund of ₹54.10 crores to meet the revised re-tendering cost of construction and development of infrastructural facilities at NIT Uttarakhand. The earlier sanctioned cost of the project under component civil work was ₹596.75 crores which now works out to the tune of ₹650.85 crores and requires additional capital loan of ₹54.10 crores. The Department of Computer Science & Engineering is planning to procure Workstations for Machine Learning Lab, and GPU Server for AI, for the Undergraduate, Post Graduate and Ph.D. Students in the Institute. In present scenario, most of the applications in Artificial Intelligence, Data mining, Computer Vision, Image Processing and other related applications require high end computation, and no such facility is available in the Institute. It is proposed to fill the vacant promotional posts of Superintendent, Technical Assistant and Junior Assistant by Direct Recruitment as no such employee would be eligible for the promotion in the Institute for an indefinite period as Institute has no such new sanctions and without the sanction of the posts in the feeder cadre, promotion is not possible on the earmarked higher positions. Due to this situation, neither the posts can be filled by promotion nor by direct recruitment, and posts shall remain vacant for an indefinite period, moreover, the Institute is in the severe shortage of administrative staff.

Hence, Board is requested to deliberate upon and approve the above proposal to meet out the essential administrative requirement of the Institute.

As per clause no.3 of contract agreement dated 19/07/2018 signed by the Dr. Kamal Kumar and Director, NIT Uttarakhand, the appointee shall be appointed as Assistant Professor (Grade-II) in the Department of Computer Science & Engineering in Pay Level 11 of the 7th CPC Pay Matrix [equivalent 6th CPC designation of Assistant Professor (On Contract) in PB-3; AGP ₹7000/-]. The basic pay of the appointee has been provisionally fixed at ₹71,000/- i.e. Cell No.2 of Level 11 of the 7th CPC Pay Matrix. The post is offered, on contract basis, initially for a period of three years which can be extended for a further period of maximum two years, beyond which no extension shall be considered.

The services of Dr. Kamal Kumar was extended for further period of two years i.e. upto 08/07/2023 vide Office Order No.A-151 dated 09/07/2021 and after the approval of the BoG vide agenda item No.BoG 34.04 dated 17/06/2021.

The contract period of Dr. Kamal Kumar was extended from 09/07/2023 to 14/08/2023 vide Office Order No.A-386 dated 06/07/2023 as per the approval of Chairman vide Note No.NITUK/R-Office/2023/ 1399 dated 05/07/2023. The contract period of Dr. Kamal Kumar was again extended from 15/08/2023 to till declaration of the result vide Office Order No.A-723 dated 26/09/2023 and the result of the faculty recruitment was declared on 15/09/2023 and Dr. Kamal Kumar joined the post on 18/09/2023 in the AGP Rs.8000/- as Assistant Professor (Grade-I) in the Department of Computer Science & Engineering.

Further, Dr. Kamal Kumar is requesting for extension of contract period from 16/09/2023 to 18/09/2023.

Moreover, Dr. Kamal Kumar has resigned and relieved from the Institute on 13/12/2023 to join the post of Associate Professor in the pay level 13(A1) at Indira Gandhi Delhi Technical Women University, Delhi.

Hence, the Board is requested to deliberate on his request.

BoG 51.29: Representation regarding promotion to the post of Deputy Registrar in NIT Uttarakhand i.r.o. Dr. Vineeta Negi Panwar.

Institute has appointed Dr. Vineeta Negi Panwar as Assistant Registrar and she joined the Institute on 10/06/2013. On satisfactory completion of the period of probation, Dr. Vineeta Negi Panwar was confirmed in the post of Assistant Registrar with retrospective effect from 10/06/2015.

In compliance to the Board of Governors, vide agenda item no.BoG 24.07 dated 16/01/2020, Board approved the recommendations of Departmental Promotion Committee (DPC) and accordingly Dr. Vineeta Negi Panwar moved to the higher Grade Pay of Rs.6,600/- with same designation w.e.f. 10/06/2018.

Institute has sanctioned one post of Deputy Registrar in the year 2017. As per recruitment method of non-teaching rules issued by Ministry of Education the criteria of filling of Deputy Registrar post 75% Direct Recruitment failing which by deputation (including Short Term contract) and 25% on promotion failing which by deputation (including Short Term contract).
